



2016 Exhibitor Information Rules & Policies

Welcome: Thank you for your interest in Smallville ComicCon! We have enjoyed growth our first two years and look forward to growing even more our third year. We appreciate your consideration of being part of a family-operated event which has been attracting world-wide attention since our very first year!

Location: Smallville ComicCon will be held in the Meadowlark Building and adjacent structures on the Kansas State Fairgrounds, 2000 N. Poplar, Smallville / Hutchinson, KS 67502. The Meadowlark Building is located near the southwest corner of the Fairgrounds, just east of Main Street. All buildings and entrances are no smoking, including electronic/vapor.

Parking: Exhibitor parking is available on the north and south sides of the Meadowlark building. The north side will accommodate trailers. There is ample access through both overhead and walk-in doors for set-up. Once the event opens to the public, all access will be restricted to the southeast entrance. **ALL FAIRGROUNDS PARKING IS FREE!!!**

Access: Exhibitor registration and entrance will begin at 5:00 pm on Friday, June 10, 2015. Upon arrival check-in with event staff to obtain your exhibitor badge and access wrist bands. Both the exhibitor badge and the access wrist band is required for entrance into the Smallville ComicCon. No one will be allowed entrance without the approved access wristband. No one will be allowed into the buildings during set-up and tear-down without an exhibitor / staff / or security badge. Security is provided by 360 Security Operations, who will be present during set-up and throughout the event until final tear-down is completed. On Friday and Saturday, the Meadowlark Building will be secured overnight with security onsite.

Lodging: Negotiations for lodging are underway and will be announced at a later date.

Booth Placement: An exhibitor's application does not guarantee them entrance to participate in this event. An exhibitor's participation and placement within the event is at the discretion of the Smallville ComicCon promoter. Placement will be made based upon the fees received and the type of exhibitor. Special needs and/or requests must be communicated to Smallville ComicCon staff and will be evaluated on a first come-first serve basis. Exhibitors may not assign their booth to a third party. Every request will be considered but understand it is not possible to accommodate all.

Wi-Fi: The wireless internet service provider for the Kansas State Fairgrounds is Wildcat WiFi, LLC. The system operates much like a WiFi Hotspot, for a fee. You will need to connect to their wireless network. "wildcatwifi", select the time package needed, pay with a credit/debit card, and then you will be permitted to use their internet service. Wildcat WiFi, LLC is an independent contracting service and is not associated with Smallville ComicCon.

Power: Electricity is available without charge through power drops to each row of booths. Exhibitors are responsible for providing their own electrical cords to access power. Depending upon booth placement, this may require a 30 foot extension cord; please prepare accordingly.

Adult-Themed Merchandise: Smallville ComicCon is a family-oriented event. We support your need to buy, sell, and trade the merchandise you commercially provide. However, during your attendance at our event no Adult-Themed Merchandise may be displayed or sold. Please take necessary precautions to insure such items are not visible to children and your booth maintains a PG rating. Your cooperation is greatly appreciated.

Behavior: Smallville ComicCon has a zero tolerance policy for harassment of any kind. Report inappropriate behavior to Smallville ComicCon staff. Reports will be professionally investigated and an appropriate response implemented as warranted.

Rules:

- Be set-up prior to and prepared for event participants during the scheduled public hours.
- Recognize and adhere to all local and state laws, including those related to collection and remission of retail sales tax.
- Be responsible for yourself, your personnel, and your merchandise, money and other property during the course of the event.
- Conduct yourself in a safe manner at all times before, during, and after the event. Do not contribute to unsafe circumstances.
- Be considerate of others and do not encroach upon the aisles and neighboring booth spaces or interfere with traffic flow and designated aisles.
- Provide safely functioning electrical extension cords and power strips.
- Clean-up your own messes.

Pet Policy: Absolutely no pets are permitted to attend the Smallville ComicCon unless they are licensed service animals.

Firearms Policy: Smallville ComicCon supports and defends your constitutional right to bear arms. Unfortunately, in an environment such as our event, the mixing of actual firearms and prop replica / costume weapons with live action role playing creates a potential for confusion and misunderstanding; which could lead to irreversible consequences. As such, the open and concealed carry of firearms at Smallville ComicCon is prohibited. Please cooperate with 360 Security Operations and their commitment to provide adequate security during our event. Thank you for your understanding.

Costume / Dress Code: Anyone is welcome to dress up when attending Smallville ComicCon, regardless if they are competing in the costume contest, LARP activities, or just hanging out. Please remember this is a family-oriented event and costuming as well as clothing in general, should be safely within a PG rating. Additional rules are available on the website; however these general rules apply for all attendees in costume:

- No partial or full nudity. Body paint, pasties, and lingerie do not qualify as a costume. Fabric must appropriately cover critical areas without risk of a wardrobe malfunction. No gratuitous display of flesh is permitted.
- No pyrotechnics, smoke, fog, fire, fireworks, explosions, concussions, etc.
- No dripping or oozing of fluids, confetti, or glitter which could create an unsafe walking surface.
- A personal wrangler is required with costumes which limit visibility, are oversized or equipped with large components or associated props. Please be mindful of people, exhibits, and merchandise around you.
- Weapons and props will be inspected at the door each time they are admitted. Weapons are required to be replica or prop by design. No illegal or functioning weapons are permitted. Airsoft/paintball and similar weapons must be unloaded, not charged with air/gas, and rendered inoperable. Peace bonding will not be required provided you police yourself.
- Smallville ComicCon staff reserve the right to deny entrance for inappropriate clothing / costumes.

This is our second annual event and the plan is to be better and we are looking forward to your contributions to the excitement within Smallville, Kansas! We look forward to you helping us make this a bigger success than our inaugural event! Terms and Conditions: The State of Kansas and the Promoter have a number of terms and conditions which are both part of the booth application and outlined in this letter available to all exhibitors. Changes will be posted to the website and Facebook page as soon as possible. Smallville ComicCon, Artistic Consultants, and Jon Robinson are not responsible for any injuries, damage, or theft occurring during this event unless the incident is a directly caused by Smallville ComicCon staff.

Cancellations: A full refund minus a 15% cancellation fee will be provided if written cancellation notice is received seven (7) days or more prior to the event (preferably e-mail). The date of the cancellation will be identified as the date Artistic Consultants or Smallville ComicCon receives the written notice. There will be no refund if cancellation occurs within the seven (7) days prior to the event. Exhibitor booth fees will not be credited toward future events. In the rare instance the event itself is cancelled, all exhibitors will receive notification by telephone and e-mail as soon as feasible, followed by a full and complete refund.
